

# **CCRA Exams**and Steno Speed Contest

#### **Steno Speed Contest**

Show off your skills at this year's annual convention and compete for the title of California's Court Reporter Speed Champion! CCRA's Annual Speed Contest is back and will consist of two five-minutes tests. The first test will be a two-voice dictation at 270 wpm, and the second test will be a legal opinion dictation at 220 wpm. Both dictations will be five minutes in duration and each candidate will have 90 minutes to transcribe each test. The top three contestants who rank the highest average above 95% on both tests combined will be awarded first, second, and third place, respectively, with the first place winner being declared the California Court Reporter Speed Champion! Requirements: You must bring your equipment. USB thumb drives will be provided to submit tests.

#### CCRA-Approved Pro Tempore Certification (Seminar & Exam)

Court versus freelance. Have you found yourself working in court lately? As a freelancer, you will find there are many obstacles and hoops to jump through to work in a civil courtroom. Join us for an in-depth discussion on the ins and outs of government work. There will be a guideline for general court work as well as one for civil appeals specifically provided and an exam after the seminar. Once you pass, there will be a certificate of completion provided.

#### **Mock CSR**

You will take the mock exam, which will mimic the actual CSR testing process, from lining up, getting your seat

number, and gaining that much-needed insight which will pay off when you do experience the real thing. Transcription will be done off site at your convenience. (Bring only your writer).

#### **CCG Skills**

The Certified CART Generalist (CCG) exam will be a 15- minute professionally recorded dictation test. The first 5 minutes will be lead-in, with the last 10 minutes graded. The examination will be given at 180 words per minute. 96% accuracy is required to pass the test (76 errors total allowed). (USB thumb drives will be provided to submit tests.)

#### **CCG Written**

A live instruction and workshop to prepare for the WKT CCG. The CCG WKT consists of 50 questions, multiple choice and true and false. The questions are mainly based on CART captioning in the classroom and the courtroom. Test takers have 90 minutes to complete the exam.

#### **CRG Skills**

The Certified Realtime Generalist (CRG) exam is a five-minute professionally recorded dictation test given at 200 Q&A with a maximum of 40 errors, 96% accuracy, with a two-minute lead-in. (USB thumb drives will be provided to submit tests.)

- AB 2531 (Gallagher) CART Providers Has passed through both the Assembly and the Senate and now sits on the Governor's desk waiting to be signed.
- AB 2757 (Reyes) Transcript Rate Increase Died in Senate Appropriations. Not enough money in CA Budget. WE WILL KEEP TRYING!
- AB 2354 (Rubio) Court Reporters in Family Law Died in Senate Appropriations. Not enough money in CA Budget, even though the Governor earmarked \$10 million.
- AB 2664 (Holden) CSRs in Civil Signed into law by the Governor on 9/18/18.

# CCRA'S Dynamex Informational Forum was a Success

On Saturday, September 8, 2018, CCRA hosted an informational forum in Sacramento to discuss the recent Dynamex ruling regarding independent contractors and how it affects court reporters. This event was open to members and non-members of CCRA free of charge. We were happy to see so many reporters in attendance!

This was by far the most informative seminar we have ever held. Our profession is changing. Those who attended want to be in front of the change; not catching up after it's too late.

Kim Lucia, with Boutin Jones LLP, went through the Dynamex decision that was determined by the California Supreme Court on April 30, 2018. This decision will affect our profession; no doubt about it. She explained the decision, as well as possible consequences and unintended consequences that may result from litigation affecting our profession.

Dan Olsen, from Abrate Olsen LLP, then explained the differences between court reporters filing as an S Corporation, a DBA, a sole proprietor, etc. He went through the pros and cons of each and how to formally file with the Secretary of State and all other required entities.

Then we heard from Seth Alexander, a business agent with United Public Employees. He explained how Unions interpret this decision and what they have planned legislative-wise and lawsuit-wise regarding this opinion. He let court reporters know how these legislative changes and/or lawsuits may affect their current and future employment options.

Brooke Ryan, immediate past president of CCRA, then discussed what the future of court reporting may look, describing the relationship of court reporters and firm owners as we trek down this new path.

There was great exchange between the participants and the speakers. The three hours were informative, enlightening, and important.

Debbie Dibble, Secretary-Treasurer for NCRA, who was in attendance, wrote the following: "INCREDIBLE meeting. Informative, efficient, and well executed. Three hours and I was learning valuable information the entire time. CCRA DOES IT RIGHT...AGAIN!!
