Section 2406 of Barclays Official California Code of Regulations, Title 16 - License Numbers Required.

"A reporter licensed under Chapter 13 of Division 3 of the Code shall list his license number on the cover page and certificate page of each deposition, court transcript, or transcript of other legal proceedings. The license number shall also be included in any and all presentments to the public including, but not limited to, advertising, solicitation, business cards, stationery, and telephone listings." As you may be aware, CCRA has been moving forward in the Legislature with AB 1293, which is a bill to expand the qualification requirements for indigent litigants in our State to access the funds in the Transcript Reimbursement Fund. You were recently sent an email

asking you to write a letter to the Governor in support of SB 1293. It is very important that we let the Governor know that we are in support of the Transcript Reimbursement Fund and would like to see the fund expanded so that more of the indigent citizens in our State qualify for its use. If you have not sent your letter yet, please do so now. Go to our web site and get the mailing information necessary.

You're in for a real treat if you attend this year's annual convention. Now is the time to register for CCRA's 96th Annual Convention, which will be held in Santa Clara at the Marriott, October 6-8. # **Cal-E-Licious**

#### **Chocolate Fruit Basket Cake**

This recipe is very yummy and easy to make.

2 devil's food chocolate cake mixes 1 basket strawberries 1-2 tbsp. sugar 1 very ripe mango 1 1/2 bananas 1 ½ pints heavy whipping cream 3-4 tbsp. powdered sugar

Preheat oven 350. Combine cake mixes and follow package instructions. Divide batter among three 9" prepared cake pans. Bake until toothpick comes out clean. Cool completely and cut the tops level. Whip cream, occasionally sprinkling with powdered sugar, until stiff peaks form. In a bowl cut up strawberries, sprinkle with desired amount of sugar and slightly mash. Do the same with the mango, omitting the sugar. Thinly slice bananas and set aside.

Place bottom cake layer on serving plate, cover with juicy strawberries and then a layer of whipped cream. Second cake layer, cut in half horizontally and gently place 1/2 on top of whipped cream; cover with mango and a layer of whipped cream, then gently place the other half on top of the whipped cream. Place bananas in a single layer on the top of this half and add whipped cream. Place third cake on top of the whipped cream and then frost the entire cake with whipped cream. 🍈

# National Committee of State Associations Update

The National Committee of State Associations (NCSA), comprised of representatives of all affiliated state associations of the National Court Reporters Association (NCRA), met in New York at the NCRA Annual convention. One of the purposes of NCSA is to allow state associations to submit resolutions to the NCSA Governing Committee for review and acceptance. If the resolution is accepted by the NCSA Governing Committee, it is brought before the entire NCSA body during its annual meeting. If the resolution is approved by the NCSA body, the resolution makes its way to the NCRA Board of Directors for consideration.

California was well represented on the NCSA Governing Committee. Two of our past presidents were on the committee: Robin Sunkees, Vice-Chair; Jan White, board member. As president-elect of CCRA, I attended the meeting and participated in voting on resolutions and presented during the Information Exchange amongst the other state leaders.

Below are the resolutions that were passed out of the NCSA meeting and on to the NCRA Board. In next month's *CCRA Online*, I will report on the content of the Information Exchange.

Resolution Number: 06-02-MN

#### Submitted by: Minnesota

**Resolution as originally submitted:** That NCRA create promotional materials to be distributed to both NCRA members and nonmembers, encouraging them to join their respective state court reporting associations.

**Rationale:** This material would help to increase membership in both associations and would also help to create an awareness of the complementary role that state associations play in the strength and future of NCRA.

**Governing Committee Recommendation:** Non-adoption of resolution as originally submitted.

**Resolution as modified:** That NCRA create promotional materials (such as informational articles) to be made available to state leaders for distribution in any format to both NCRA members and nonmembers, emphasizing the importance of being members of their state association as well as the national association.

**Rationale:** This material would help to increase membership in both associations and would also help to create an awareness of the complementary role that state associations play in the strength and future of the profession.

**Governing Committee Recommendation:** Adoption of resolution as modified.

**Governing Committee Rationale:** Increasing membership is an area in which NCRA has expressed a commitment. State associations are better acquainted with their public relations and promotional needs on a local/regional basis. NCRA staff can prepare information and data and make this information available to state leaders. From that juncture, state leaders can use what they need in the proper format to disseminate information to prospective members and students. This material would help to increase membership in both associations and would also help to create an awareness of the complementary role that state associations play in the strength and future of the profession.

Vote of NCSA Body at Annual Meeting: Adoption

Resolution Number: 06-03-RC

Submitted by: NCSA Governing Committee

**Resolution:** That NCRA amend language concerning employment practices and postings in all NCRA publications to include pregnancy, marital status and political affiliation. NCRA publications should state that *NCRA will not accept employment advertising that indicates a preference in terms of race, color, sex, national origin, age, disability, pregnancy, marital status, religion, sexual orientation, or political affiliation.* 

**Rationale:** NCRA should uphold the laws enforced by the US Equal Employment Opportunity Commission (EEOC) and extend those laws to protect the interests of members of the profession who seek employment through various NCRA publications.

Governing Committee Recommendation: Adoption

**Rationale:** NCRA should uphold the laws enforced by the US Equal Employment Opportunity Commission (EEOC) and extend those laws to protect the interests of members of the profession who seek employment through various NCRA publications.

Governing Committee Recommendation: Adoption

Vote of NCSA Body at Annual Meeting: Adoption

Resolution Number: 06-04-MS

Submitted by: Mississippi

**Initial Resolution:** That NCRA promote reciprocity certification among state licensure laws for members holding the minimum of RPR certification for those states seeking passage of licensure laws in an effort to promote cohesiveness in national standards of state certification laws and encourage amenable professional state association relations.

**Substitute Resolution:** That when a state is seeking to adopt certification requirements, NCRA advocate recognition of the RPR as meeting that state's certification requirement.

**Rationale:** Encourage maintenance of NCRA membership. Encourage better relations and promote professionalism among fellow reporters and state associations. Promote maintenance of the profession in areas where there is a huge shortage, thus promoting the drive toward ER.

By way of explanation, this is an incentive to promote several venues:

Encourage maintenance of NCRA membership. (If a member doesn't see continued benefit of maintaining a RPR in states that do not acknowledge the RPR, what incentive is there to continue maintenance of the designation and membership to NCRA? A continued drive by states to require "their" state testing for certification minimizes the notion of the RPR being the "national" minimum standard.)

Encourage better relations and promote professionalism among fellow reporters and state associations. (Creates a harmonious professional relationship between reporters of states when seeking certification and licensure from other states, rather than creating friction and division between reporters and states and state associations, thereby building a better professional rapport.) Promote maintenance of the profession in areas where there is huge shortage and thus, promotes the drive toward ER. (In bordering states for many reporters, there are locations where no licensed reporters live, thereby placing the attorneys at a disadvantage by not having a reporter and being left with the alternative of either tape, digital, or video recording. Where a reporter may opt to take the state test, there is the additional expense of testing in addition to licensure fees.)

Creates an incentive for members who move from state to state without having to retest and bear additional expenses when they already meet the national standard and most likely state standards and have to pay ever-increasing membership dues to national. (There has been a constant concern about loss of national association membership and the increase of dues. Where a reporter only is required a state certification and also maintains the RPR, it will be more cost-effective to pay the state licensure rather than pay for both state licensure and national certification. If there is an incentive for flexibility from state to state, the reporter is likely to maintain the RPR and thereby, continue national membership and state licensure as well.)

# **Merriam Webster**

thank-you-ma'am \THANK-yoo-mam\ noun

: a bump or depression in a road; *especially* : a ridge or hollow made across a road on a hillside to cause water to run off

Example sentence:

"That night on the way home, thinking of his pleasant visit, he was suddenly shaken out of his tranquility ... when his touring car hit a 'thank-you-ma'am' in the unpaved road." (Hugh Manchester, *Centre Daily Times* [State College, PA], August 22, 2000)

#### Did you know?

"Thank-you-ma'am" might seem like an odd name for a bump in the road, but the expression makes a little more sense if you imagine the motion your head would make as you drove over such an obstacle. Most likely, the jarring would make you nod involuntarily. Now think of the nodding gesture you make when you're thanking someone or acknowledging a favor. The "thank-you-ma'am" road bump is believed to have received its name when someone noted the similarity of those two head bobbing motions. It's a colloquialism particular to American English, and its earliest printed use is found in Henry Wadsworth Longfellow's 1849 prose piece, *Kavanagh*: "We went like the wind over the hollows in the snow; — the driver called them 'thank-you-ma'ams,' because they make every body bow."

Job's comforter \JOHBZ-KUM-fer-ter\ noun

: a person who discourages or depresses while seemingly giving comfort and consolation

Example sentence:

When Tracey's second interview didn't go well, more than one Job's comforter remarked that she probably would have hated the job anyway.

#### Did you know?

**Poor Job.** He's the biblical character who endures extraordinary afflictions in a test of his piety. He loses his possessions, his children, and his health. And then, to make matters worse, three friends show up to "comfort" him. These friends turn out to be no comfort at all. Instead, they say that the things that have been happening to him happen to all sinners — and point out a number of his faults. In the mid-18th century, English speakers began using the phrase "Job's comforter" for anyone who offers similarly unhelpful consolation.

#### AB 1293 Oropeza

Transcript Reimbursement Fund.

Location: 08/31/2006-A ENROLLMENT 08/31/2006-A EN-ROLLMENT

**Status** 08/31/2006-Senate amendments concurred in. To enrollment.

#### Calendar

Existing law establishes the Court Reporters Board of California and makes it responsible for issuing a certificate to practice shorthand reporting to qualified applicants. Under existing law, until July 1, 2011, funds generated by the initial certificate fee collected by the board, as specified, are used to provide shorthand reporting services for indigent persons, as defined, and deposited into the Transcript Reimbursement Fund at the beginning of each fiscal year. Notwithstanding any other provision of this article, a transfer to the Transcript Reimbursement Fund in excess of the fund balance established at the beginning of each fiscal year shall not be made by the board if the transfer will result in the reduction of the balance of the Court Reporters' Fund to an amount less than six months' operating budget. for expenditure for that purpose. This bill would revise the definition of indigent person for these purposes and would make the program funding shorthand reporting services from the Transcript Reimbursement Fund inoperative on July 1, 2009, and would repeal it on January 1, 2010, unless a later-enacted statute changes those dates.

#### AB 1588 Negrete McLeod

#### Professional licensing boards: review and repeals.

Location: 02/02/2006-S B., P. & E.D.02/02/2006-S B., P. & E.D.

Status 02/02/2006-Referred to Coms. on B., P. & E.D. and JUD.

#### Calendar

This bill would give the Joint Committee on Boards, Commissions, and Consumer Protection the burden of demonstrating, among other things, that its function of licensing and enforcing licensing standards is the least restrictive regulation consistent with the public health, safety, and welfare. The bill would apply to the Court Reporters Board, if passed.

#### AB 1797 Bermudez

#### Trial courts: limited-term employees.

Location: 08/31/2006-A ENROLLMENT 08/31/2006-A ENROLLMENT

**Status** 08/31/2006-In Assembly. Concurrence in Senate amendments pending. Senate amendments concurred in. To enrollment.

#### Calendar

Existing law defines the term "trial court employee" for pur-

poses of the Trial Court Employment Protection and Governance Act. In defining this term, the act provides that any temporary employee shall not be employed in the trial court for a period exceeding 180 calendar days, except for court reporters under certain conditions. This bill would provide that a limited-term employee is a regular trial court employee if the assignment, position, or project of the limited-term employee is an integral part of the long-term, regular work of the trial court. The bill would state legislative intent to prohibit the trial courts from classifying long-term employees that are performing the regular work of the trial courts as limited-term employees. This bill would additionally provide, in Los Angeles County, that a limited-term employee, including, on and after November 1, 2007, any limited-term law clerk, is a regular trial court employee if the assignment, position, or project of the limited-term employee is an integral part of the longterm, regular work of the trial court.

#### AB 1995 Koretz

#### Trial court employees: personnel files.

Location: 08/28/2006-A CHAPTERED 08/28/2006-A CHAPTERED

**Status** 08/28/2006-Chaptered by the Secretary of State, Chapter Number 187, Statutes of 2006

#### Calendar

Existing law requires each trial court to permit an employee to inspect his or her official personnel files that are used, or have been used, to determine that employee's qualifications for employment, promotion, additional compensation, or termination or other disciplinary action. This bill would make that requirement applicable to any personnel files.

#### AB 2863 Karnette

#### Public employees: retirement.

Location: 08/31/2006-A ENROLLMENT 08/31/2006-A ENROLLMENT

**Status** 08/31/2006-Urgency clause adopted. Senate amendments concurred in. To enrollment.

#### Calendar

Existing law provides for the compensation and benefits of court reporters in specified counties. This bill would provide that the compensation of regular official court reporters in Fresno County shall be determined by collective bargaining between the court reporters and the superior court. The bill would also define, for purposes of retirement, the compensation of a regular official court reporter in Fresno County, as specified. This bill is to take effect immediately.



#### SB 56 Dunn

#### Trial court judges and officers.

Location: 08/31/2006-S ENROLLMENT08/31/2006-S ENROLLMENT

**Status** 08/31/2006-Senate concurs in Assembly amendments. (Ayes 38. Noes 0.) To enrollment.

#### Calendar

This bill would, among other provisions, provide 50 additional judges to be allocated, upon appropriation by the Legislature in the 2006-07 fiscal year to various county superior courts. The bill would require the Judicial Council, on or before November 1, 2007, to adopt, and report to the Legislature annually thereafter upon, judicial administration standards and measures that promote the fair and efficient administration of justice. This bill would require, on or before March 1, 2007, and annually on or before each March 1 thereafter, all of the following: (a) the Governor to disclose aggregate statewide demographic data provided by all judicial applicants relative to ethnicity and gender, (b) the designated agency of the State Bar responsible for evaluation of judicial candidates to collect and release statewide demographic data provided by judicial applicants reviewed and the statewide summary of the recommendations of the designated agency by ethnicity and gender, and (c) the Administrative Office of the Courts to collect and release the demographic data provided by justices and judges relative to ethnicity and gender by specific jurisdiction.

#### SB 395 Escutia

#### California Court Facilities Bond Act of 2006.

Location: 07/05/2005-AAPPR.07/05/2005-AAPPR. Status 07/05/2005-From committee: Do pass, but first be rereferred to Com. on APPR. (Ayes 6. Noes 3.) Re-referred to

#### Com. on APPR.

#### Calendar

Existing law, the Trial Court Facilities Act of 2002, establishes the State Court Facilities Construction Fund and provides that money in that fund may be used to acquire, rehabilitate, construct, or finance court facilities, as defined, and to implement trial court projects, as specified. This bill would enact the California Court Facilities Bond Act of 2006 which would authorize, for display purposes only, the issuance, pursuant to the State General Obligation Bond Law, of an unspecified amount in bonds, the proceeds of which would be deposited in the 2006 California Court Facilities Bond Act Construction Fund for specified purposes relating to the acquisition and maintenance of court facilities, including payment of a county's share of building costs in a shared-use court facility. This bill contains other related provisions.

#### SB 1476 Figueroa

#### Professions and vocations.

Location: 08/31/2006-S ENROLLMENT08/31/2006-S ENROLLMENT

**Status** 08/31/2006-Senate concurs in Assembly amendments. (Ayes 22. Noes 15.) To enrollment.

#### Calendar

This bill would extend the sunset review process for the Court Reporters Board by one year, making the Court Reporters Board inoperative on July 1, 2009, and would repeal it on January 1, 2010, among other provisions concerning other boards.

#### SB 1852 Committee on Judiciary

#### Maintenance of the codes.

Location: 08/10/2006-S ENROLLMENT 08/31/2006-S ENROLLMENT

SCA 16 would divide the Los Angeles Superior Court into judicial districts. The proposed constitutional amendment would create the potential for separate and distinct collective bargaining agreements and personnel policies, procedures or rules for each judicial district as opposed to one collective bargaining agreement and one set of policies, procedures or rules that uniformly affect all employees of the Los Angeles Superior Court.

Last month our realtime troubleshooting scenario concerned what if the realtime feed from the reporter's computer to counsel's computer was not working. **As a refresher,** remember in that scenario there could be any number of solutions, but the first option is to make sure that your com port on your CAT system output is appropriate. You can do this by going to the Device Manager, which you find under Control Panel – System – Hardware – Device Manager. Then once in Device Manager you click on the plus sign next to the Ports (Com & LPT) and a list of com port devices will be listed. Find your specific type of cable listing and the com port will be indicated in parens. That's the com port designation that you want to select in your CAT output.

I had requested from you, the reader, to email me with troubleshooting episodes you have experienced. I received one such episode that I would like to discuss this month.

Have you ever had trouble inserting your serial adapter into a Dell computer's serial port? Coincidentally, I had three realtime reporters have this very same problem over the past month. Personally, I have never experienced this issue, but it is a common occurrence if you do not use the appropriate serial port adapter. You can solve this problem by making sure the serial adapters you buy are not too large to fit into that Dell serial port. What do I mean? The Dell computer has a larger plastic piece that surrounds the serial port, and if you do not have a "smaller" or "regular" serial adapter that you use to hook to their computer, this problem will occur.



So when buying the cables, multi-line block, DSD, and serial adapter, be sure to ask the company if they are compatible with the Dell's serial port!

# Which Do I Choose, Courts or Depositions?

# Working for the Courts (Part 2 of a 2-part series)

Depositions are fascinating. They can also be a well-paying facet of your court reporting career. The flip side is they can be boring. (Read worker's comp depositions here.) And occasionally it takes forever to get paid with small claims becoming a necessary step to get an invoice paid.

Now that the two extremes are out of the way, let's focus on the nuts and bolts as I see them and some of the reasons that I have for those two statements.

You set your own hours – kind of. You can choose to take a deposition on a certain day at a certain time or you can choose not to work that day. But if you're not working, you're not getting paid. You still are in control of your own time more than if you are an official. If you're an official reporter and your court is in session, so are you. If you're not writing when your court is running, it's either because you've got an understanding supervisor who will let you work on your transcripts or you're taking some of time off with pay that you've earned by being an employee.

As a depo reporter the faster that your clients want their transcripts, the more money you're able to make. Expedites, dailies, rough ASCIIs, rush jobs all present the opportunity for you to market your skills and charge more for your services.

Depositions offer you the opportunity to meet many new people. Some deposition reporters in larger metropolitan areas rarely see the same attorneys twice. In the smaller rural areas, you see the same attorneys often and you're able to develop friendships on both a professional and a personal level. On the other side of that coin, a downside to being a deposition reporter is what is commonly referred to as being isolated from the rest of the reporting profession. I have spoken with reporters that have talked of never meeting the people that run the deposition firm that hired them. They are called for a job, arrive at a new client's office, take the deposition, go home, edit the job, email it to the hiring firm, mail the exhibits, and then they wait for their payment. If you're a social person, you should consider this as a possible downside.

Being a deposition reporter allows you the chance to work in different locations each time that you have a job. Some reporters have traveled to different states as well as different countries to take depositions with their clients. In college I worked for a reporter in a deposition firm who had taken Imelda Marcos's deposition. I've spoken with reporters from the Los Angeles area who had taken the depositions of rock stars as well as movie stars and professional athletes. I attended a real time seminar with the deposition reporters that did the deposition of then President Bill Clinton in the Monica Lewinsky matter.

So as you can see, the opportunity to meet what many consider fascinating people on a more personal level is possible in the deposition world depending on where you choose to hang your shingle or take your jobs.

The choice in the end is yours and what you feel most comfortable with. From my experience, a career that includes both depo and court work is really the best of both worlds.
