

#### Ink Cartridge Shelf Life

- Q. What is the shelf life for unopened ink cartridges? I have two in my office that have been sitting there for about a year. Are they still good?
- A. Generally speaking, the industry-estimated shelf life for an unopened printer cartridge is two years. "Unopened," within this context, refers to remaining factory sealed in its air-tight wrap.

Even though that is the estimated shelf life, I have used cartridges that were five years old and they were fine. A lot depends on the conditions within which they are stored. It's one thing to store a cartridge in a room-temperature office; it's quite another to leave it in the trunk of a car, in an unheated, uncooled garage, or on the porch if you happen to live in a rain forest.

- Q. I have the opportunity to purchase a used Mac laptop, sight unseen and of an uncertain age, at a very low price. I would like your opinion as to whether it is practical to purchase it, have it gutted and reinstalled with the appropriate programs. I have a repairman who charges a flat \$50 to do whatever needs to be done to fix a computer, plus parts. What do you think?
- A. First, do you want a Mac? They're great computers, but so are Linux systems. If you have always wanted something other than a Windows PC, this might be a chance for you to obtain one. On the other hand, are you only interested because this particular computer came to your attention?

If your answer to my initial query is yes, that you always wanted an Apple system, the next question is, "What are you really purchasing?" I would not

purchase any computer sight unseen or without knowledge as to its age and condition, and the specifics of any warranty. (It does have a warranty, doesn't it?) I also would not consider purchasing it without having it checked out by a reputable Apple-certified technician.

If you have confidence in your repair person — and it is unusual for any reputable technician to provide a flat-fee service without regard to the amount of time any repair will require — the other issue is the cost of parts. Apple parts are not inexpensive. If the system you're contemplating purchasing ultimately needs several hundred dollars worth of new parts, why bother? If it's what we in the biz refer to as an old beater, and you invest in all kinds of new components, it's still going to be an old beater that you then have far too much money invested in.

Personally, I would not consider it an "opportunity" to buy somebody's old computer without knowing a LOT more about it. Keep in mind that one person's opportunity is another person having found a sucker to unload something on. Bottom line: Caution is advised.

- Q. Is there any way I can organize my iPad apps into folders? Thanks, Mr. M.
- A. If you have oodles of apps on your Home screen(s), you can tidy things up by using folders to group similar apps. To create a folder, press and hold an app icon until it starts to jiggle. Using your finger, drag it on top of another app. Voila! Both apps are now in the same new folder. You can drag additional apps into any folder to create a nice collection of similar apps. You will need iOS 4.2 or higher (the operating system) to use this function. For additional life-altering iPad tips, check out http://amzn.to/nw7pif.

#### **Use Arrow Keys for Text Selection**

- Q. Isn't there some way to use the arrow keys when highlighting text? I try to use my mouse cursor, but I always end up overshooting the mark or selecting an entire paragraph when I only want a few words or a sentence or two.
- A. There is indeed a way to use your arrow keys to select text. Place your cursor where you want to start highlighting, hold down your Shift key, then use your up and down arrow keys. If a section that you want to highlight is really large, use your Page Up and Page Down keys.
- Q. I'm using the latest version of Microsoft Office, but for the life of me, I cannot find the Close All command that I had in previous versions. Can you help, Mr. M?
- A. The Close All command comes in handy when you have multiple files open and you want to close them in one swell foop. It still exists, but it's hidden so it needs to be nudged out into the open which you can do with the Quick Access Toolbar, located by default in the upper left corner of the screen.

Use the down arrow to the right of the Quick Access Toolbar to select the More Commands option. Within the Customize category, use the drop-down list on the left to choose All Commands > Close All. Use the Add button to place it on the list for the Quick Access Toolbar, followed by OK. You will then be able to execute the Close All command from the Quick Access Toolbar.

Q. I terminated my AT&T account for my smartphone because I didn't need all the Internet-related bells and whistles. Even though I no longer have Internet access by phone, can I continue using the phone's calendar, camera, etc? I'd consider selling it, but I don't know why anybody would want a year-old phone. Thanks for always providing honest, reliable answers, Mr. M. A. Honest? Reliable? Whew. I'm really feeling the pressure, but I'll do my best: Different phones function in different ways, so if the calendar and camera aren't dependent on Internet access, you should be fine, though you won't be able to forward photos and other items. If the calendar is Webbased and you were using your cell phone's wireless connection to the Internet, you will not be able to access that feature. The easiest way to check is to simply power up the phone and see what you can and cannot do.

As far as selling your phone, there are many people who do want older phones, particularly folks who may not be able to afford newer ones. If you do decide to sell it, Gazelle.com is one of several popular (and legitimate) outfits that buys and sells older technology.

- Q. At the top of my computer screen it shows my current printer and two other printers that I have not had for sometime. How can I remove these two former printers? I'm using Windows XP, if that makes any difference.
- A. Click Start > Settings > Printers and Faxes. You will see your printer icons there. Right-click any printer you want to remove and select Delete. Restart your computer and the icons will be gone with the wind.

#### The Quandry of the Apostrophe

Margie Wakeman Wells is the author of the definitive work on punctuating the transcript, <u>Court Reporting: BadGrammar/Good Punctuation</u>, and an accompanying <u>Workbook</u>.

Margie has given over 300 seminars around the country on punctuation and English for reporting organizations around the country and always presents at the CCRA convention.

We continue to struggle with the use of the apostrophe, seeing it used incorrectly over and over. Let's assume we know *they're* from the other two forms and the difference between *its* and *it's*. (No such thing as *its'*.)

A recent question was "Do we use an apostrophe in homeowners' association?" The answer is that formal English says it needs the apostrophe; the reality is that most reporters do not use it.

However, if we are going to use it, there are many homeowners. It has to be plural possessive: ...homeowners' association. There is more than one worker: ...workers' comp.

Names keep cropping up with the apostrophe in the wrong place. When a surname has the word *the* in front of it, it is ALWAYS plural.

- ...talked to the Millers at the dealership...
- ...were not involved with the Hansons...

When the word needs to be possessive, make it plural first; then add the apostrophe.

- ...talked to the Millers' son at the dealership...
- ...were not involved with the Hansons' case...

If a name ends in s, z, or x, make it plural by adding -es. Then make it possessive.

- ...saw the movie with the Wellses...
- ...saw the movie with the Wellses' son...
- ...had dinner with the Foxes...
- ...had dinner with the Foxes' son...
- ...called the Ruizes...
- ...called the Ruizes' lawyer...
